enclosed envelope. Written proxies need to be received by the independent proxy until June  $22^{nd}$ , 2021. Should he receive no other written instructions, the independent proxy is instructed to abstain from voting pursuant to Art.10 Sec. 2 Swiss Ordinance Against Excessive Pay at Publicly Listed Companies (VegüV). This is the case as well, should the Annual Shareholders' meeting decide on motions not mentioned in the invitation.
